STRUCTURE OF THE WORLD RADIOCOMMUNICATION CONFERENCE (WRC-93) Geneva, 1993

The agenda of the Conference appears in Resolution 1032 which was adopted by the Council at the final meeting (20 December 1992) of its 47th session.

Bearing in mind Nos. 356 to 367 inclusive of the Convention of the International Telecommunication Union, Geneva, 1992, the following committees with their terms of reference are suggested. These terms of reference have been drawn up within the framework of the Constitution and Convention, the Conference agenda and in the light of experience at previous conferences.

Committee 1 - Steering Committee

Terms of reference :

To coordinate all matters connected with the smooth execution of work and to plan the order and number of meetings, avoiding overlapping wherever possible in view of the limited number of members of some delegations (No. 360 of the Convention, Geneva, 1992).

Committee 2 - Credentials Committee

Terms of reference :

To verify the credentials of delegations and to report on its conclusions to the Plenary Meeting within the time specified by the latter (No. 361 of the Convention, Geneva, 1992).

Committee 3 - Budget Control Committee

Terms of reference :

To determine the organization and the facilities available to the delegates, to examine and approve the accounts for expenditure incurred throughout the duration of the Conference, and to report to the Plenary Meeting the estimated total expenditure of the Conference, as well as an estimate of the costs that may be entailed by the execution of the decisions taken by such a conference (Nos. 364 to 366 of the Convention, Geneva, 1992).

Committee 4 - Agenda Committee

Terms of reference :

On the basis of proposals from administrations:

1. To make recommendations for the agenda for the 1995 WRC, including:

1.1 The review of the Radio Regulations based on the report of the "Voluntary Group of Experts to Study the Allocation and Improved Use of the Radio-Frequency Spectrum and the Simplification of the Radio Regulations",

1.2 Any guidance on facilitating the use of frequency bands allocated to the mobile-satellite service,

2. To make recommendations for the preliminary agenda for the 1997 WRC.

Committee 5 - Editorial Committee

Terms of reference :

To perfect the form of the texts to be included in the Final Acts of the Conference without altering the sense, for submission to the Plenary Meeting (Nos. 362 and 363 of the Convention, Geneva, 1992).

Draft agenda for WRC-95

RESOLUTION

The World Radiocommunication Conference (Geneva, 1993),

considering

a) Resolutions 8 and 9 of the Additional Plenipotentiary Conference, Geneva, 1992;

b) Article 13 of the Constitution (Geneva, 1992) regarding the competency and scheduling of world radiocommunication conferences and Article 7 of the Convention (Geneva, 1992) regarding their agendas; and

c) the relevant Resolutions and Recommendations of previous World Administrative Radio Conferences;

recognizing

a) that the work of the VGE should be considered and implemented as quickly as possible, to ensure that future decisions of the Radiocommunication Sector are made within the framework of any new substance, structure or arrangement of the Radio Regulations;

b) that activities related to the planning of the mobile-satellite service consequential to the decisions of WARC-92 indicate that some of those decisions may require clarification;

c) that the use of frequencies in the fixed-satellite service for feeder links for nongeostationary-satellite networks are an integral aspect of facilitating the use of the frequency bands allocated to the mobile-satellite service and both services may benefit from additional guidance by the Conference;

considering further

a) that the increase in status in Article 8 to the space services in the band 2 025 -2 110 MHz was not accompanied by an appropriate change to the limits in Article 28 to ensure compatible sharing conditions with terrestrial services sharing the band on an equal basis;

b) that the urgency of some of these matters and the short duration of this Conference has required the adoption of Resolutions which provide temporary guidance until these matters can be considered in detail by the World Radiocommunication Conference, 1995;

c) that there are many possible solutions open to the Radiocommunication Sector on some of these issues including those which may arise from the work of the Radiocommunication Study Groups;

resolves

to recommend to the Council that a world radiocommunication conference be held in Geneva in late 1995 for a period of four weeks, with the following agenda:

1. to review the report of the Voluntary Group of Experts; to take action as appropriate to revise the Radio Regulations; and to provide a clear timetable for the resolution of any outstanding items; USA/7/1, CAN/9/1, J/10/1, EUR/11/1, B/17/1, ARS/19/1, AUS/20/1, IND/25/1, KEN/26/1, Document 28/4

2. to consider the possibility of bringing forward on a worldwide basis the date of entry into force of the allocation to the mobile-satellite service in the bands 1 980 - 2 010 MHz and 2 170 - 2 200 MHz and to take action as necessary; CAN/9/1, EUR/11/1, B/17/2, AUS/20/1

3. to consider the frequency allocation and regulatory aspects of providing feeder links to mobile-satellite systems, especially those using non-geostationary orbits, and to take action as appropriate; USA/7/1, CAN/9/1, EUR/11/1, B/17/3, ARS/19/1, AUS/20/1

4. to review the procedures [and provisions] for the coordination of mobile-satellite systems and for the sharing of the mobile-satellite service with other services, in particular Resolutions Nos. 46, 70, 212 and 213, and Recommendation No. 717, and to take action as appropriate; EUR/11/1, B/17/4, ARS/19/1, AUS/20/1, F/24/1

5. to consider raising to primary status the allocations to the meteorological-satellite and Earth exploration-satellite services in the bands 401 - 402 and 402 - 403 MHz, as indicated in Resolution No. 710; J/10/2, EUR/11/1, IND/25/1

6. to review No. 855A of the Radio Regulations, in accordance with Resolution No. 112;

7. to consider frequency allocations and associated provisions for the band 399.9 - 400.05 MHz; USA/7/1 (paragraph 1.3)

8. to consider the possible deletion of all secondary and permitted allocations from the band 136 - 137 MHz, which is allocated to the aeronautical mobile (R) service on a primary basis, in accordance with Resolution No. 408 and in order to meet the special needs of the aeronautical mobile (R) service; EUR/11/1

9. to give initial consideration to proposals and views on the options to improve the effectiveness and efficiency of Appendices 30 and 30A of the Radio Regulations for Regions 1 and 3, with a view to WRC-97 undertaking further action; AUS/20/1, F/21/1, EUR/30/1

10. to consider proposals for inclusion in Article 28 of power limits for earth stations of the Earth exploration-satellite, [space operation] and space research services in the band 2 025 - 2 110 MHz; CAN/9/1, AUS/20/1

11. to assess spectrum requirements for MSS and feeder links to be considered by WRC-97; USA/7/... (paragraph 3);

12. in accordance with Article 7 of the Convention (Geneva 1992):

15. to consider the changes to the Radio Regulations consequential to the introduction of FPLMTS; B/17/5



REPORT OF THE BUDGET CONTROL COMMITTEE

TO THE PLENARY MEETING

1. The Budget Control Committee held two meetings during the World Radiocommunication Conference and considered the points arising under its terms of reference.

2. Under Nos. 364 to 366 of the Convention, Geneva, 1992, the Committee's terms of reference are :

a) to determine the organization and the facilities available to the delegates ;

b) to examine and approve the accounts for expenditure incurred throughout the duration of the conference ;

c) to present a report to the Plenary Meeting showing the estimated total expenditure of the conference as well as an estimate of the costs that may be entailed by the execution of the decisions taken by such conference.

3. Organization and facilities made available to delegates

3.1 Although the Radiocommunication Assembly and the World Radiocommunication Committee were organized in parallel, the Budget Control Committee considered that the facilities made available to delegates were very satisfactory and wished to express its thanks for all the efforts made to ensure the smooth running of the Conference.

4. <u>Financial responsibilities of Conferences</u>

4.1 The attention of the Budget Control Committee was drawn to Article 34 of the Convention (Geneva, 1992) which stipulates that :

"1. Before adopting proposals or taking decisions with financial implications, the conferences of the Union shall take account of all the Union's budgetary provisions with a view to ensuring that they will not result in expenses beyond the credits which the Council is empowered to authorize.

2. No decision of a conference shall be put into effect if it will result in a direct or indirect increase in expenses beyond the credits that the Council is empowered to authorize".

5. Budget and expenditure of the World Radiocommunication Conference

5.1 The Council, at its 47th session in 1992, provisionally entered in the 1993 budget a credit of 1,580,000 Swiss francs for the convening of the first World Radiocommunication Conference pending an appropriate decision of the Additional Plenipotentiary Conference in December 1992. Since then, this credit has been broken down as follows : 1,026,000 Swiss francs for the Radiocommunication Assembly and 554,000 Swiss francs for the World Radiocommunication Conference.

5.2 The budget of the World Radiocommunication Conference was adjusted to take account of changes in the conditions of employment of staff in the United Nations Common System and of the Swiss franc/US dollar exchange rate. It stands on 1st November 1993 at 566,000 Swiss francs.

5.3 The table in Annex I to this report sets out the expenditure of the World Radiocommunication Conference as estimated on 15 November 1993. It emerges that the total expenditure is estimated at around 476,000 Swiss francs, thus leaving a provisional saving of 90,000 Swiss francs.

6. <u>Financial implications of the decisions taken by the Conference</u>

6.1 No additional expenditure resulting from the execution of the decions taken by the Conference can be foreseen.

7. <u>Contributions of entities and organizations to the expenses of the Conference</u>

7.1 Article 33 of the Convention, Geneva 1992, provides that the entities and organizations which have been authorized to participate in a radiocommunication conference shall share in defraying the expenses of the conference in question unless they have been exempted by Council.

7.2 According to No. 481 of the Convention, Geneva 1992, the amount of the contributory unit for entities and organizations which contribute to the expenses of that Conference amounts to 1,480 Swiss francs. The contributions are considered as Union income.

7.3 The list of entities and organizations which participate in the work of the Conference is found in Annex 2 to this document.

The Plenary Meeting is requested to consider and approve this report, which will then be forwarded to the Secretary-General, together with the comments of the Plenary meeting for submission to the 1994 Council.

PLENARY MEETING

NOTE FROM THE CHAIRMAN OF THE CONFERENCE

Fulfilling the task given to me by the Plenary Meeting of Wednesday, 17 November, 1993, and after lengthy consultations, I hereby submit the following suggested addition to Draft Res. [] concerning the Agenda for the WRC 95.

Insert after the present "considering" the following new text:

" considering further

a) that the World Administrative Radio Conference, WARC-92, allocated the frequency bands 1970-2010 MHz and 2160-2200 MHz in Region 2, and 1980-2010 MHz and 2170-2200 MHz in Regions 1 and 3 to the Mobile-satellite service on a primary basis as of 2005;

b) that this Conference recommends to the Council to include in the agenda of the 1995 World Radiocommunication Conference the review of the above date;

c) that some administrations expressed the wish to start the coordination procedure contained in Resolution 46 as soon as possible due to the long time that may be required for the completion of that coordination;

d) that some administrations already submitted information on projected mobile-satellite networks,

recognizing further

that the administrations shall comply with the provisions of the Final Acts of WARC-92 without prejudice to the decisions to be taken by the WRC-95 in respect of the matters referred to in "considering further" above.".

Insert after "resolves" § 2.1. the following new § 2.2:

"2.2 following review of the date mentioned in the provision No. 2.1 b) above to also review and take decisions on the status of those satellite systems of the Mobile-satellite service in the above bands which have been published before WRC-95 as well as those which may be published before the date reviewed."

Insert after the existing text in "invites administrations" the following text as a new, second paragraph:

"2. to cooperate in coordination consultations referred to in "considering further c)" above to facilitate the early identification and resolution of any coordination difficulties.".
