World Radiocommunication Conference and Radiocommunication Assembly 1993

ITU's new regime of biennial World Radiocommunication Conferences (WRC) and associated Radiocommunication Assemblies (RA) will be inaugurated in November 1993, at Geneva. Preceded by the RA from 8 through 16 November, the WRC will be held from 15 to 19 November.

The WRC will propose agendas for conferences to be held in 1995 and 1997. Key topics for 1995 will certainly include comprehensive *review and simplification of the international Radio Regulations*. The basis will be the Report of the Voluntary Group of Experts (VGE), and its draft revised Radio Regulations, to be completed in March 1994. The 1995 WRC is expected also to consider procedures to facilitate *the use of frequency bands allocated to the mobile-satellite service*. Further items for the 1995 and 1997 agendas will depend on proposals by administrations to the WRC-93. ITU Council will approve final agendas, dates and venues at its meetings in 1994 and 1995.

The Radiocommunication Assembly replaces the former CCIR Plenary Assembly. It will set the structure, programme, and working methods of Study Groups for the two-year period to 1995. An *Ad Hoc Advisory Committee for Strategic Review and Planning (CCIR Resolution 106)* and a *Working Party on Study Group Structure (CCIR Resolution 107)*, in a number of meetings with wide participation, prepared more than 10 draft Resolutions to aid RA decisions on organizational matters, liaison, and cooperation with other organizations. The new Convention reinforces the role of Study Groups to prepare for WRCs, so particular attention will be given to the conference preparatory group structure. There is also keen interest in how best to carry out other studies on procedural and regulatory matters. Very few "ITU-R" Recommendations on technical and operational matters will be considered, as most have been approved by administrations by correspondence.

The limited agenda of WRC-93, and the brief duration shared by the Assembly and the Conference, are unprecedented. They fit the needs of the new ITU activities in radiocommunication and remain within the budget previously planned for the Assembly itself.
